REGISTRATION / REFEREE / RESCHEDULE GAME FEE STRUCTURE

SPRING 2022

INDIVIDUAL PLAYER/COACH FEES –

ClubTeam Ages U9-U19 – Need to be on roster for verification By March 28, 2022 for team ages 9-19 to avoid late fees being assessed.

- \$ 0.00 ea – players returning from Fall 2021 or new / returning coaches (Grassroots teams) (coach background check / safety requirements / coaching licenses, are to be paid by club/coach separately).
- \$16.00 ea – new player (Grassroots teams)
- \$12.00 ea – player fee upgrade from grassroots to competitive level (allows for tournament play outside of GAASA)
- \$28.00 ea – new player, existing/new coach / assistant coach / manager (Competative teams)

GAASA High School Teams – This is for individual players wanting to play on a high school soccer team and not associated with a club. Limit 5 players per high school (seniors do not count towards limit). Players need to be registered by March 28, 2022 to avoid late fees.

\$125 ea – new HS player (Grassroots)

Note: U18 & U19 players defined as an Adult Athlete must comply with the Ohio Soccer Association (OSA) for SafeSport Screening. (Refer to <https://ohio-soccer.org/safesoccer/safesport/?ss-policy> for additional information.) Players shall cover their own costs to be compliant, Note: OSA may offer reimbursement for a portion.

CLUB TEAM FEES - (paid in both fall & spring season)

- Team fee = \$80, U9-U10
- Team fee = \$90, U11-U12
- Team fee = \$100, U13-U15
- Team fee = \$110, U16-U19

Clubs will be invoiced separately for team fees and new players/new coaches per above.

LATE FEES if applicable

MARCH 28 – APRIL 11, 2022 – 10:00 PM

\$10.00 - Additional for each transaction in addition to individual players/coaches/managers as listed above.

APRIL 11 – May 2, 2022 – 10:00 PM

\$25.00 – Additional for each transaction in addition to individual players/coaches/ managers as listed above.

RESCHEDULES - \$100 after the stated deadline as announced each season.

YOUTH REFEREE FEES

Referee fees are to be paid on the field at game time with **each** coach responsible for the fees stated below. Referees receive Double the fees listed below. Fees shall be paid in full, even if all referees are not present.

| U14/U15 division 1, High School Divisions | \$22/14/14 each game (3 referees) |

PLAYOFF FEES

- All fees are payable at playoffs. Club's balances must be paid prior to participating in playoffs.
- Team fees: \$120 each, plus applicable referee fees (listed above) for the semi-finals game. The 3-man referee fees at the finalist game will be paid for by GAASA.

CLUB WITH OUTSTANDING BALANCES – Effective March 1, 2018

- \$25 – Per month for outstanding balances 30-60 days
 - \$100- Per month for outstanding balances 61-120 days
 - \$200 – Per month for outstanding balances 120+ days
